Launch-in-Time Game Terms and Conditions

Game Terms and Conditions for Aark Digital Launch-in-Time Game

These Terms and Conditions for Launch-in-Time ("Game Terms and Conditions") govern your participation in the Aark Digital Launch-in-Time Game (the "Game") provided by Aark Digital ("we", "our" or "us"). By participating in the Game, you agree to comply with these Game Terms and Conditions. By participating in the Game, Participant also agrees to all the conditions in the general Terms and Conditions provided on Aark Digital's website. If there are any conflicts between the two documents, these Game Terms and Conditions shall prevail. Please read them carefully. Participants acknowledge their compliance with these Game Terms and Conditions and agree to adhere to all applicable federal, state, and local laws, rules, and regulations.

1. Eligibility

The Game is open to individuals who are residents of countries or territories where the Game is legally available, as determined by Aark Digital in its sole discretion. Participants must be at least eighteen (18) years of age or the legal age of majority in their jurisdiction. Employees, officers, and representatives of Aark Digital, as well as their immediate family members, are not eligible to participate in the Game.

2. How to Play

The Game will begin and end at the times specified by Aark Digital (the "Game Period"). Details on how to play and participate in the Game will be provided by Aark Digital. Participants must follow the instructions and rules set forth by Aark Digital to enter and play the Game.

3. Prize

Aark Digital may offer prizes ("Prize") to Participants of the Game. Aark Digital reserves the right to substitute the Prize with an alternative if necessary. 4. Winner Selection and Notification

Winners of the Game will be selected by Aark Digital according to the criteria specified by Aark Digital at its sole and exclusive discretion. The selection process may include factors such as gameplay performance, completion of specific tasks, or other relevant considerations.

Winners will be notified by Aark Digital within a reasonable time after the end of the Game Period. Aark Digital will use the contact information provided by Participants to notify the winners. If a winner cannot be reached or fails to respond within a specified timeframe, the winner may forfeit the Prize.

5. Liability Release and Indemnity

 NECESSARY INFORMATION AND MATERIALS AS PER RELEVANT LAWS
 OR GOVERNMENT ORDERS TO VERIFY THE LEGALITY OF THE SOURCES
 AND USE OF THEIR FUNDS.
